The Board continues to work with the township to communicate our concerns and seek solutions. ## Vice President Report - Adam Parsons

With increase use of properties, we want our members to stay safe, health and protect the environment around them. Here are a few reminders that are sometimes overlooked:

- Smoke Detectors ensure to replace batteries 2X per year and replace detectors over 10yrs old. Test your detectors frequently
- Septic Tanks Have your septic clean and inspected at regular intervals. If you are using your property more frequently, adjust your maintenance schedule to reflect usage. Inspection reports must be submitted to the town on a regular basis
- Fires It is forbidden to burn leaves or refuse in Tiny Township with violators facing fines. These items should left for pickup or be taken to transfer site on Golf Link Rd.

On the CPOA website there is a list of local contractors our members had a positive experience with. Reference this when looking for a recommended contractor as a starting point – in the end the choice relies with you. #### Secretary Report - Andrew Chomentowski

## **Gypsy Moth infestation**

Township staff is preparing a policy which may allow property owners to aerial spray their land, which is adjacent to Township property, with a bacterium naturally found in the soil, to control the infestation. This control method is considered safe for humans and used in many areas of Ontario. Tiny Township is identified as a heavily infested area; however, it appears that there are lands that are affected more than others. Several Beach Associations have reported significant defoliation in their area. We have had only a few reports of infestation at Cawaja. ## **New Parking Restriction Dates and Fines**

Largely based on last year's experience, Township staff recommended an increase in length to the Permit Parking period (April 15 to October 15). Township staff also suggested that fines for parking violation should be increased significantly because the current rate was not an effective deterrent. Reminder: it is unlawful to charge for parking on personal property.

### **Controls on Short Term Rentals (STR)**

Tiny Township Council has instructed staff to determine what other municipalities are doing and to provide recommendations so that regulations can be implemented for the 2021 season. There are more than 300 identified STR properties in Tiny at this time. Neighbours of STRs have complained about noise, overcrowding, parking and a disrespect of others. When the regulations take effect, if you have STR concerns in your areas please contact the Township.

## New Garbage Carts

New carts with plastic wheels and lids will be delivered to addresses beginning in the summer and through the fall. The organics carts will utilize a gravity operated cart lock to help eliminate the potential for entry by animals.
